Obligations on entry

Because of immigration laws, it is compulsory for immigrants who travel in or out of Holland (Schengen-country), to report at the duty officer at the immigrationpoint.

To ignore these instructions is a punishable offence.

Immigrants, entering from countries other than Schengen-countries mentioned here under, have to report on entering.

When you entered directly into the harbour of Vlissingen, Middelburg, Zierikzee, Colijnsplaat and Veere you are requested to fill in the faxform CREWLIST, being a entry form, in triplicate and:

- send one form to the duty officer at the immigration point at Vlissingen,
- 2 copies have to stay on board during your stay in a Schengencountry.

The faxform can be obtained from the harbour master.

Having filled in the CREWLIST, being an entry form, and having sent it away,

you are considered to have fulfilled your obligation for entry into a Schengen-country.

When the harbour master is unavailable, we request that you make telephone contact with the immigration officer at the immigration point in Vlissingen.

There is a possibility of on board spot checks.

The immigration point in for the harbour Breskens is: Terneuzen. Faxnumber 0115-670777.

The indicated immigration points for Zeeland are: Vlissingen, (portable office) and Terneuzen (portable office).

In Belgium is the same procedure. When you have a stamp at your Crewlist from the Belgium Borderpolice it is not neccessary to fax a Crewlist to the Duch immigration point. When their is a check on board in Holland you show this Crewlist. When you have no stamp, then you need to fax a new Crewlist to the Duch immigration point.

When you arrived in the Duch harbour, you can ask at the harbour master if he send by fax
